The A34 from the M4 to the M40 is already overstretched and dangerous. As a regular user it has to be avoided at rush hours, all Friday afternoons and is frequently closed or journeys delayed because of accidents. The current plan does not adequately consider the specific local traffic issues associated with the juxtaposition of a major road of national importance and the limited river crossings available and in particular how they are affected by flooding and the knock on effects for surrounding towns and roads.

The improvements to A34 access North of Abingdon are not guaranteed and the plans for Abingdon's South development including a new river crossing seem to have been forgotten or dismissed. The current proposal are unsound, cannot be delivered and lack strategic long-term thinking.
