English Heritage welcomes the references in the Spatial Vision to new development respecting local character, protecting the Vale's outstanding and distinctive natural and built environment and conserving and enhancing its important heritage.

However, the Vale's important heritage should be conserved and enhanced through other measures, not simply through new development, and this should be an objective in its own right as part of a positive and clear strategy for the conservation, enjoyment and enhancement of the historic environment as required in local plans by the NPPF and in line with the tenth core planning principle in the Framework to "conserve heritage assets in a manner appropriate to their significance......". We would also prefer "protecting...natural, historic and built environment...." as not all historic features are "built".

The third paragraph of the Vision should be amended to read:

The important historic heritage of the Vale will have been, and will continue to be, conserved and enhanced. New development will have respected the local character of the Vale, protecting its outstanding and distinctive natural, historic and built environment. High design......climate change.

This would accord with paragraphs 17 and 126 of the NPPF.

English Heritage welcomes the reference to the built and natural heritage in Strategic Objective SO3, although we would prefer "built, historic and natural" as not all historic features are "built" or "natural".

We also welcome the reference to the historic and cultural assets of the Vale in SO11, which effectively repeats SO3.

However, we would welcome a specific objective "Conserve and enhance the historic environment including designated and non-designated heritage assets", to mirror SO10 for the natural environment and as part of a positive and clear strategy for the conservation, enjoyment and enhancement of the historic environment as required in local plans by the NPPF. This would also be in line with the tenth core planning principle in the Framework to "conserve heritage assets in a manner appropriate to their significance......"

In itself and in isolation, English Heritage does not consider that these omissions are sufficient to render the Local Plan unsound, but when taken in combination with a number of other omissions and amendments we have identified. we consider that the Plan does not quite set out the positive strategy for the conservation and enjoyment of, and clear strategy for enhancing, the historic environment required by paragraphs 126 and 157 of the NPPF (see our comments on Policy 39).



It is our understanding that Elms Parade is a 1930's shopping parade that defines the character of the area and is a much-loved and much-used local heritage asset. It is In our view, it is inadequate simply to require a new development to be of at least equal architectural merit – this will not retain the Parade's historic or communal significance. It appears to us to be contradictory for the Plan to encourage the redevelopment of the Abbey Shopping Centre and the Charter to improve the retail offer and vitality of Abingdon town centre and yet also propose the loss of an existing active shopping area in Botley. The NPPF recognises that heritage assets are an irreplaceable resource that should be conserved in a manner appropriate to their significance.

In addition, Policy 11 fails to include any requirement for any redevelopment to avoid any adverse impact on views to and from Oxford. We would also welcome criterion iv being more positive i.e. requiring proposals to enhance the character and appearance of the area in accordance with the requirement of paragraph 157 of the NPPF for local plans to contain a clear strategy for enhancing the historic environment. or sound, having regard to the test you have identified at 5 above where this relates to soundness. 

English Heritage welcomes and supports Core Policy 39 as a strategic policy for the conservation and enhancement of the historic environment, as required by paragraph 156 of the NPPF, and as part of the positive and clear strategy for the conservation, enjoyment and enhancement of the historic environment as required by paragraphs 126 and 157 of the NPPF (but see comments below on the evidence base).

We note that a number of historic environment policies are still saved from the Local Plan 2011, and consider that these provide the complementary development management policy or policies we feel are necessary as clear policies on what will or will not be permitted and where and to provide as clear indication of how a decision maker should react to a development proposal as required by paragraphs 15 and 154 of the NPPF respectively.

We will, of course, expect these to be replaced in due course by a new development management policy or policies in the future Local Plan Part 2, which should include guidance on development affecting Conservation Areas and on development affecting non-designated assets, both of which appear to be currently lacking. The NPPF sets out a number of requirements for local plans in respect of the historic environment:

- set out a positive strategy for the conservation and enjoyment of the historic environment [126];
- include strategic policies to deliver the conservation and enhancement of the historic environment [156];
- contain a clear strategy for enhancing the natural, built and historic environment [157];
- identify land where development would be inappropriate, e.g. for its environmental or historic significance [157];
- be based on adequate, up-to-date and relevant evidence about the historic environment [158, 169 and 170].

English Heritage's Historic Environment Good Practice Advice in Planning Note 1: The Historic Environment in Local Plans, (Consultation Draft published July 2014 http://www.english-heritage.org.uk/content/imported-docs/f-j/gpa1-he-local-plansconsultation.pdf) provides advice meeting these requirements.

As regards the adequate, up-to-date and relevant evidence base to underpin the strategy and policies of the Local Plan which, although the last of the requirements above, is the starting point, the Good Practice Advice Note advises that it is important to bear in mind that this is not simply an exercise in setting out known sites but, rather, in understanding their value to society (i.e. their significance) of sites both known and potential.

The Note also advises that it may be helpful to collate the information about the historic environment in a Heritage Topic Paper. We therefore welcome the Council's Topic Paper 8 "The built environment and historic environment". We note the conclusion in paragraph 4.2 of this Paper that "The Vale is lacking a robust evidence base for the conservation and enhancement of the historic environment", a concern we raised when commenting on the draft Local Plan last year.

The Council's response to this conclusion is to include a policy within the Local Plan setting out how the Council will improve its understanding of the historic environment through producing an evidence base. It could be argued that a policy seeking to ensure an adequate evidence base rather defeats the object as the Local Plan should be <u>based</u> on an adequate, up-to-date and relevant evidence base. This is particularly important as the Local Plan Part 1 allocates 21 strategic development sites.

However, we have noted and welcomed the references in the Plan to the Oxfordshire Historic Landscape Characterisation and Historic Environment Record, which are both important components of the evidence base, and suggested that a reference be included in paragraph 6.94 explaining how existing Conservation Area Character Appraisals have formed part of that evidence base.

We also suggest a reference to the Oxford View Cones Study in Core Policy 44 (or its supporting text), which also forms part of the evidence base as noted in the Council's Topic Paper 8. There is also a reference in the Plan to English Heritage's Heritage at Risk Register.

Ideally, the strategic development allocations and other policies and proposals in the Local Plan would have been informed by character assessments of the historic towns in the Vale. However, we have assisted the Council in using the Oxfordshire Historic Landscape Characterisation in assessing potential strategic allocations, which we consider satisfies paragraph 170 of the NPPF.

With the other references to the evidence base, both existing and suggested, English Heritage is satisfied that the Local Plan Part 1 is underpinned by an adequate, up-todate and relevant historic environment evidence base and therefore satisfies paragraphs 158 and 169 of the NPPF.

However, we do not consider that the evidence base is adequate for the more detailed policies and smaller site allocations to be included in the proposed Local Plan Part 2. English Heritage will therefore be expecting the Council to make progress in producing Conservation Area Character Appraisals and Management Plans as in line with the commitment in Core Policy 39. In addition we would encourage the Council to commission or undertake character assessments of the historic towns in the Vale and to consider the preparation of a heritage strategy for the district as a whole. We would be pleased to advise the Council on the preparation of such a strategy.

We have explained above that we are satisfied that Core Policy 39 satisfies the NPPF's requirement for a strategic policy for the conservation and enhancement of the historic environment of the Vale. However, following our comment above, we would welcome a commitment in the Policy to the preparation of character assessments of the historic towns in the Vale and a heritage strategy for the district.

In developing the "positive strategy for the conservation and enjoyment of the historic environment" required by paragraph 126 of the NPPF, the NPPF advises that local planning authorities should take into account:

- the desirability of sustaining and enhancing the significance of heritage assets and putting them to viable uses consistent with their conservation;
- the wider social, cultural, economic and environmental benefits that conservation of the historic environment can bring;
- the desirability of new development making a positive contribution to local character and distinctiveness; and
- opportunities to draw on the contribution made by the historic environment to the character of a place.

In addition, English Heritage believes that it is clear from the Government's use of the words and phrases "seeking positive improvements", "positive strategy", "deliver the conservation and enhancement" and "a clear strategy for enhancing" in the NPPF that the Government is expecting local planning authorities, through their Local Plans, to actively <u>deliver</u> the conservation and enhancement of the historic environment"; it is not sufficient for local planning authorities to be passive or merely reactive in the conservation and enhancement of their historic environment.

It is English Heritage's view that a "positive" strategy for the conservation and enjoyment of, and a "clear" strategy for the enhancement of, the historic environment, comprises more than a strategic policy and (in this case) saved historic environment development management policies. Our Good Practice Advice Note 1 explains our view that "a strategy to conserve heritage assets potentially engages all aspects of planning". We therefore look for recognition of the importance of the historic environment to the character, economy and quality of life of the Borough through references throughout a Local Plan. There are a number of references to the historic environment throughout the Plan that we have welcomed. In our view, however, these do not quite fully comprise or demonstrate a positive or clear strategy. It is for this reason that we consider the Pre-Submission Local Plan to be unsound as it stands. We have suggested additional references (particularly in respect of paragraph 3.1 and Core Policies 11 and 14) which, if added to the Plan, would, in our view, result in the Plan containing the positive and clear strategy required by the NPPF. We would then consider the Plan to be sound in this respect.

We suggest that the Council consider whether it would be appropriate to identify land where development would be inappropriate for its historic significance (in accordance with paragraph 157 of the NPPF) when preparing the Local Plan Part 2.



However, we would welcome specific reference to protecting the green setting of Oxford and views from the three viewpoints in the Vale identified in the Oxford Views Study (Raleigh Park/Harcourt Hill, Boars Hill and Hinksey Hill A34 Interchange), although we recognise that this might be more appropriate for a more detailed landscape/views policy in the Local Plan Part 2.

In itself and in isolation, English Heritage does not consider that this omission is sufficient to render the Local Plan unsound, but when taken in combination with a number of other omissions and amendments we have identified. we consider that the Plan does not quite set out the positive strategy for the conservation and enjoyment of, and clear strategy for enhancing, the historic environment required by paragraphs 126 and 157 of the NPPF (see our comments on Policy 39).



The eastern boundary of the site is on the line of the Aelfrith Ditch which, although not scheduled, may still be of national significance, in which case paragraph 139 of the National Planning Policy Framework would apply. We would like to see an additional principle, perhaps in a new section on "historic environment and cultural heritage", requiring development to retain and respect the line of this earthwork. 



English Heritage makes no comment on the merits or otherwise of this site allocation but we welcome the requirement for a Heritage Statement to be submitted to show how the listed buildings at Monks Farm and Grove Wick Farm have been sensitively considered. Monks Farm is a good rural group with a farmhouse, barn and cottages, and surrounding this group with housing and a link road can only, in our view, seriously harm the setting of these buildings. It is critical therefore that, if this allocation is taken forward, the impact on setting is mitigated as much as possible through limiting the scale of the surrounding development and sensitive design.

The route way (Cow Lane) which runs through the allocated site, is at least postmedieval in date, appearing on Rocque's map of Berkshire in 1761. This historic feature should be retained and respected within any development scheme. An additional requirement should be added to the Site Development Template requiring the retention of and respect for this historic route. This comment is without prejudice to any comments we may wish to make on any future planning application for the development of this site. 6. 
