Figure 5.1 Subject to comments on policies Core Policy 3 omit North Hinksey as "smaller village" from the Figure map.

The identification of North Hinksey as smaller village on figure 5.1 is inconsistent with the higher level Adopted Policies Map which makes no reference to North Hinksey on the basis that it forms part of the Botley inset. This is further reinforced by the Council's Green Belt Review (November 2014) that examined the Green Belt around Botley (page 4 of the Review) where Site 11 has been identified as being removed from the Green Belt as part of the amendment to the Green Belt around the Botley inset. This further reinforces the points made in these representations and the Core Policy 3.

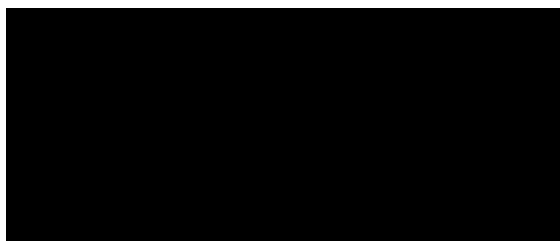
