INTRODUCTION >

This bulletin is the ninth in a series of progress updates on the Vale of White Horse District Council's Local Plan

LOCAL PLAN 2031 PART 2 SUBMISSION

Vale of White Horse District Council submitted the Local Plan 2031 Part 2: Detailed Policies and Additional Sites to the Secretary of State on Friday 23 February 2018 for independent examination.

Following Submission of the Part 2 plan, the Secretary of State will appoint a Planning Inspector to carry out an independent Examination to assess if the Plan meets the Government's requirements for Local Plans. Please see our **Guidance Note** for further information.

The Inspector will take into account all representations received from the Publication Version of the Part 2 plan.

The Council has appointed a Programme Officer, Ian Kemp, who will work on behalf of the Inspector and independently of the district council. The Programme Officer will be in contact with relevant parties to provide details of the examination, when known. Further information and updates will be available on the Council website and will be included in our next Local Plan Update Bulletin.

SUPPLEMENTRY PLANNING DOCUMENTS

The Council is preparing Supplementary Planning Documents (SPDs) for Harwell Campus and Dalton Barracks. The SPDs will set out a comprehensive development framework for both these sites in accordance with the Part 2 plan. The SPDs will be a material consideration in assessing future planning applications for both sites. They will provide more detailed guidance ensuring the successful comprehensive development of Harwell Campus and Dalton Barracks.

The Council has undertaken initial engagement, earlier this year, with key stakeholders to inform the preparation of the SPDs.

We continue to support neighbourhood plan groups across the district in preparing their plan. The Planning Policy Team provide support for towns and parishes in preparing their vision and objectives and other informal guidance for preparing planning policies.

The team has recently supported Wootton and St Helen Without Neighbourhood Plan Group in facilitating engagement with younger people during the initial stages of preparing their neighbourhood plan.
