Plan is unsound as it has not been positively prepared. Details of infrastructure required to accommodate additional vehicle movements from 1,000 new homes has not been provided. A new cycle route through Sunningwell has been proposed for a new park and ride scheme but this is poorly conceived. The people who can afford to buy a house are not the type of people to cycle to a park and ride to get to Oxford. Also, traffic will be heading in the opposite direction and towards Abingdon. Parents will need to drive into Abingdon to take children to school, adding further pressure on Faringodn Road, Elm Tree Walk and Barrow Road. For the plan to be sound, information needs to be provided on how new infrastructure is to direct traffic away from these routes. The Lodge Hill slip road upgrade will be needed before homes are built.

For the plan to be sound, information needs to be provided on how new infrastructure is to direct traffic away from Faringdon Road, Elm Tree Walk and Barrow Road from vehicles entering/leaving the new development towards Abingdon. The Lodge Hill slip road upgrade will be needed before homes are built as this will help for vehicles trying to head northbound on the A34. There is sufficient space on the site so that development can be focused on the north of the site to create a separate village entirely, protecting the existing Shippon village, which avoids the need for existing houses in Shippon to be removed from green belt land. Improving the junction between Long Tow and the Wootton Road will direct some traffic travelling toward Abingdon down the Wootton road towards some secondary schools. An outer ring road from the current entrance to the airfield at Barrow Road to Whitecross will also help take traffic away from the existing Shippon village, which is already a 'rat run' for parents taking their children to the private schools and Larkmead. The development should be planned so that Faringdon Road, Barrow Road, Elm Tree Walk and Cholswell road do not become main access roads for the new development into Abingdon (particularly the end of Faringdon Road at the gates to the airfield, and elm tree walk as these roads can only currently accommodate one direction of traffic).
