Dear Nina,

Many thanks for your email.

I am fully aware that the Inspector of Part 1 of the Local Plan allowed you 2 years to produce Part 2, however, I assume that in doing so he also expected that the reports that inform the plan would be accurate?

The Open spaces audit may well have taken place in 2015. However, Humpty Hill was recommended for addition to the Town Green Register in September 2015 and OCC voted to do so 30th November 2015 (the town green application was made in 2013). Although the actual amendment of the register did not take place until spring 2016, following a failed judicial review, the land was in law a Town Green from September 2015 (a green become a green whether registered or not, please see Oxford Trap Grounds case at the High Court 2005).

I accept that it is possible that your policy officers were unaware of this, although probably unlikely as Humpty was also subject to a failed planning application in 2014 and was provisionally allocated as Local Green Space in the Neighbourhood Plan, an allocation which also failed.

The existence of the Town Green application was extensively discussed in meetings with your neighbourhood plan officers years before. Further to this, one would assume it is the job of policy officers to be aware of such situations.

I am certain that your senior policy officer, Andrew Maxted, was aware that Humpty was a Town Green on 13th July 2016, some 4 months before the Draft Open Spaces Report was published, as he attended the Faringdon Neighbourhood Plan Inquiry where this was discussed.

If the report is not amended I will write to the Inspector to inform him of this inaccurate report and lodge a complaint with the Vale. Apologies form my stern position on this but reports should be correct and it should be possible to amend a draft report. Particularly one which was inaccurate before it was even published.

> by December 2018. Therefore we do not have the time to reproduce the

> Humpty Hill does not need protecting by Local Plan Policies. It's a town green! The highest level of land protection  
available? Your Policy 32 somewhat pales into insignificance.

> The point I am making is a with the broader view of the town. The report will inform policy and decisions but is  
inaccurate by some 14 acres. An enormous amount of open space for a town the size of Faringdon. Policy is now  
being written based on known faulty information. It makes a mockery of the process.

> The report is in draft. It needs to be amended. If this was just a small area of land it would perhaps not be  
significant, but it's 14 acres. One assumes that the purpose of a draft report is to allow amendments?

>> Thank you for your email regarding the draft Open Spaces Report published in 2016, in particular your query related to Humpty Hill Town Green, Faringdon.  
>>  
>> The open space audit to inform the draft report was undertaken in 2015, before Humpty Hill Town Green was registered, therefore it has not been included within this draft Open Spaces Report (2016).  
>>  
>> However, I can confirm that Humpty Hill Town Green will be protected by the local planning policies in the emerging draft Local Plan 2031 Part 2: Additional Sites and Detailed Policies. For example, development of open space will be assessed in accordance with Development Policy 32: Open Space in the emerging Local Plan 2031 Part 2, where proposals will need to demonstrate a number of criteria, including the need to replace the loss of open space with an equivalent or better provision in terms of scale, quantity and quality in a suitable and accessible location.
