As a civil engineer, I believe you have not suitably addressed the growing traffic congestion problems which already exist on the A420 near Kingston Bagpuize. Traffic congestion is already a major problem in this area and with the addition of 600 new homes it will be almost inconceivable. The road is single carriage and already caters for a huge amount of traffic into Oxford every morning. For those turning onto the road from surrounding villages such as Fyfield it currently can take up to 10 minutes just to join the road and sometimes up to an hour to get into Oxford - four times the usual travel time. The 66 bus is often delayed by an hour or even more in the mornings due to this traffic. I do not believe that any amendments you propose to this traffic plan will overcome this with the addition of 600 new homes.
