Thank you again for a great update. Can I please ask where you stand on the latest VoWh plan? They are still planning on building in an AONB and still have no regard for small rural villages merging into one, the ability for the infrastructure to cope with traffic and children in schools as well as the sustainability in and around Didcot. With the new homes planned in Didcot, the surrounding areas cannot cope with this influx of housing in the villages as well, as well as this vast expansion of Harwell.

Also, again they have not included the 275 houses recently built in Chilton in these plans and it means that it is going to TREBLE in size. I not only feel for us as residents in Chilton, I feel for Oxon as a whole, as the VoWH seem keen to build on any area of open green land they want, as well as setting a precedent for the rest of the lovely AONB in Oxon and other counties to be destroyed and built upon.

I will obviously use the forms to voice my concerns, but I'd like some re-assurance that AONB stay protected, otherwise there is no hope for us as a nation, let alone a county.
