The proposal that five Green Belt sites around Cumnor village are to be removed from the Green Belt is contrary to Government Policy and no explanation is given as to why this is necessary. The strategic site in South Cumnor (numbers 6 and 24) has already

been withdrawn from the plans because of its unsuitability for housing. Therefore it should remain in the Green Belt. Sites 4 and 5 were concluded to be inappropriate in the Green Belt review as they are within the Cumnor Conservation Area . It was concluded that "removing them from the Green Belt would serve no purpose". The Vale should therefore change its policy on removing them from the Green Belt. Site 3 in Cumnor adjoins the extremely busy and noisy A420 and would remove the clear break between the village and the A420. It should also be removed from the plans. The Green Belts were originally designated for good specific reasons and there are no good reasons to re-examine their Green Belt status. Once land is lost from the Green Belt it is lost forever. At a more general level a recent report by the University of the West of England concluded that a minimum of 976,000 homes could be built on identified brown field sites. The potential use of brown field sites in Oxfordshire should be a high priority. Any removal of sites from the Green Belt leaves these sites wide open for speculative development. This is inevitable as, due to the inflated SHMA numbers, the Vale will be unable to meet its housing targets.
