Government policy is to protect the Green Belt. This Local Plan is in direct contravention of that policy. The aim of the Green Belt was to prevent further urbanisation and conurbation and this principle should not be flouted, especially as the Government is committed to policies which maintain the health, happiness and well-being of the nation. Public footpaths into neighbouring villages will also be spoilt. Once built on, the Green Belt and its associated nature and wildlife will be lost forever not only to us but to all future generations.

Air pollution in this area of the Thames Valley is already officially recognised as too high. Since living here, my daughter has developed asthma. The extra vehicles on the roads as a result of the Local Plan will reduce air quality further still. Housing developments cannot be undertaken in the knowledge that it will further deteriorate public health here.

The traffic situation itself is already congested and difficult to cope with. There are already too many pressures on the estate, for instance I was unable to secure a place at the local school, despite living only 5 minutes walk away and waiting times for appointments with the family doctor have lengthened significantly.
