We are concerned that the policy states that housing needs assessments need to be undertaken in accordance with a methodology agreed with the District and Parish Council. We are well aware of numerous examples across the country where Parish Councils refuse to undertake such surveys or plans as an excuse for them not to have any pressure placed upon them to deliver rural exception sites. In terms of the reference to the Green Belt and that such proposals would not undermine the purposes or visual amenities of the Oxford Green Belt; it is important to note that the NPPF under Paragraph 89 confirms that affordable housing for local community needs (which is what rural exception sites aim to provide for) are defined as exceptions to inappropriate development in the Green Belt.
