Abingdon is an Historic Market Town. The urban sprawl into Green Belt land is progressively destroying it unique character, and views from and towards the high land to the north of the town. Public Footpaths

into neighbouring villages and countryside will be overwhelmed by the scale of development. The ancient woodland (Blake's Oak) is immediately outside the boundary of the North Abingdon development and would be impacted by it.
