The proposed housing in North and northwest Abingdon will be right alongside the A34 ?with attendant noise and pollution problems that will be difficult to mitigate. Developing the A415 will have the effect

in INCREASING traffic through the town unless an eastern bypass were constructed avoiding Bridge Street. Whilst mentioned there is no proposal for this river crossing nor the other supporting infrastructure which would need to be extensive.
