Since 70% of the new jobs identified In the Vale plan are associated with the Science Vale to the south of Abingdon, placing housing to the North/north-west of Abingdon will place additional stresses on the

already congested road network; the distances are such that walking and cycling) are not really an option; buses do not serve these routes. The vulnerability of A34 and lack of alternative routes leads to severe congestion at peak times on the ring road, on roads into the centre of Abingdon, over the Thames Bridge, and on the A34. Increased traffic through Abingdon to Culham Science Centre, and round the orbital road will increase air pollution in the town.
