The plan is unsound in these ways:

Policy 13? Five sites around Cumnor village are proposed for removal from the Green Belt, saying that the areas "no longer fullfil the purpose of the Green Belt". This is untrue. The Green Belt areas of Cumnor have served very well to maintain the character and appearance of the village. Cumnor is largely a ribbon development along the roads that meet at its centre. The Green Belt areas specifically maintain this character. Their removal (and subsequent inevitable development), will lead to a dense, built up area. In fact the council itself said of sites 4&5 in the draft local plan "these" sites are located in the Cumnor Conservation Area. The Cumnor Conservation Area Character Appraisal specifically refers to them as important to the character of the Conservation Area. On this basis, these sites would not be supported for development and therefore removing them from the Green Belt would serve no purpose". The Government's own guidelines state that Green Belt land canot be re-allocated to fullfill unmet housing need. The Council should be invited to state what has changed since the draft plan was written, and why key guidelines are being ignored.

- 1. There must be a full and transparent consultation on the re-drawing of Green Belt boundaries.
- 2. Housing allocation must be reduced in line with the Government's own forecasts. If this were done, there would be sufficient available land without stealing from the Green Belt.
- 3. Adequate transpost provision must be made to allow residents of new and existing settlements to go about their business in a timely manner. This must include new rail stations outside existing towns to give rail access to the new housing, major exapnsion of capacity of the A34, or a scheme to separate N-S traffic from local traffic west of Oxford, and a guarantee of increased bus subsidies
