The North Abingdon site has been extended to the East of Oxford Rd into the area of Peachcroft Farm. In the green belt review carried out in February 2014 and a key piece of the evidence base for the plan, it is not recommended that any land east of Oxford Rd be released from the green belt. The landscape and visual impact assessment carried out in august 2014 can in no way supercede the green belt review, otherwise it opens the possibilty of constant review. NPPF recognises that green belt boundaries can only be changed in exceptional circumstances and no mention is made of any such exceptional circumstances that occured between February and August.
