The scale of the proposed development in Radley is unacceptable. The original Draft Plan proposed an increase of over 700 homes within the parish boundary, where there are currently about 900 homes. The current Draft Plan has raised the increase to over 1000 by adding the Eastern Extension to the North Abingdon site, land which lies in the Parish of Radley. The original North Radley site, although now removed from the plan, would still be removed from the Green Belt (why?) thus leaving it vulnerable to future development.

About 500 Radley residents responded to the first draft in April using a standard letter produced by the Parish Council. These were all considered as one objection, despite assurances from the Vale of White Horse District Council Leader on 4th April that they would be considered individually.

The Vale Council also admit that there were problems with its website during the initial consultation. I can't know if any comments were lost as a result, but the Parish Council is aware of an extension being granted to key landowner, Radley College, whose response is dated 11/04/2014 a full week after the close. No such extension was offered to the public.

The SHMA itself is just a starting point and only part of the evidence base for determining housing need and further work needs to be done to test whether it can be accommodated sustainably before adopting it as a housing target. The VoWHDC should not adopt the SHMA figures unquestioningly and must undertake this further work before adopting the SHMA figures; In particular, the figures must be properly assessed against local and regional social, environmental and infrastructure considerations.

The projected housing demand on which the Plan is based, (the SHMA) is excessive and needs to be revised and based more closely on the Government's own household projections .
