If the developments do not come forward on the timescale adopted by the Vale there will be a serious funding shortfall. ? The Plan implicitly acknowledges this fact when in Chapter 4 page 40 it writes ?If housing growth does not take place in the ring-fence area, Enterprise Zone and other business growth would be harmed and business prospects rates? contributions to infrastructure provision jeopardised.? ? Surprisingly

having recognise this problem the Vale does not develop the point further. Social ? I support the CPRE?s comments concerning the social and environmental issues.
