The proposed building on the fields East and West of the Oxford Road North of Abingdon will irrevocably change historic landscape and the setting of Abingdon in the countryside. The past extension of Abingdon to the North sensitively created an effective boundary for the Town. The use of walling around the Peachcroft and Long Furlong estates along with the continuous ribbon of road created the impression of a wall medieval moated town, entirely suitable for a historic town like Abingdon. The North entrance to the town is pleasantly situated in the landscape. This will all be lost if the current plan is approved.
