I live in East Hanney and wish to object to the proposed building of 200 homes in the Village.

On the "Local Plan 2031 Part1: Appendix 8: East Hanney" the land to the South of East Hanney (EHAN05B) is shown as being undeliverable due to a combination of access constraints, a water course through the plot and flooding risk to the North. For some reason this is shown as deliverable on the "Local Plan 2031 Part 1: Consultation on the draft plan".

The land to the South of East Hanney is next to a Flood Zone 2. The increased run off from this development will lead to increased flooding and pressure on the water courses. In particular the North part of this plot already floods. Building on this plot is madness - it will flood at some point and it will contribute to flooding in the rest of the village. These are not called the "Island" villages for nothing the region around them traditionally floods. Earlier this week the Government announced £297M for flood defences in the Thames Valley - mostly to fix the problems caused by inappropriate This development would be against sections 100.101.102.103 of the National Planning Policy Framework.

The previous version of the plan "Local Plan 2031 .. Housing Delivery Update - Feb 2014" showed development to the East of the A338. At the "consulation" meeting on the 31st March 2014 the option of a development to the South of the village was not raised and it was a shock to find that location of the site had been changed. This was not a preferred location as some documents have suggested.

This development will destroy the character of the village.

A related issue is the role of the council in all of this. These are our elected representatives who have been forced into taking these measures by central government. They are not acting in our best interests and have resorted to threatening us by saying things along the lines of "If you do not accept plan A then you will be forced to accept plan B - which will be worse". Why bother to vote in the council elections when there is no representation? This is a fundamental failure of the democratic process.
