I consider the plan is unsound. It states Abingdon has excellent public transport links with Oxford but in my opinion this is incorrect. I commute by bus from North Abingdon to Oxford. There is only one main regular bus service run by Oxford Bus Company - there are no train links. I think it is incorrect to describe a single bus service as being "excellent". During rush hour this service is running over capacity already - by the time a bus reaches North Abingdon from at rush hour there is regularly no seats left and frequently no standing room either. Returning from Oxford to North Abingdon in the evening I frequently have to wait for a subsequent bus as there is not room on the first one. In addition the bus service uses the A34 and so any issues with the A34 means journey times can easily double as you are stuck in traffic. In summary Abingdon's public transport links with Oxford are poor - a single bus service already struggling to cope with demand and frequently delayed by the A34 traffic issues
