There has been insufficient time for consultation and the process is both complicated and difficult.

The proposal is not sound. The site will dramatically change the character of the village, which has

already been subject to considerable enlargement in recent years. This is a village with a large Conservation Area and many character houses. This development will increase the size of the village by more than half.

The village is designated as large, which is factually incorrect. There is no church, the school is shared with West Hanney, there is only a poor community shop, the travelling library is about to be discontinued, the Hall is shared with West Hanney, there are very few other facilities.

The site is outside the village envelope. It is on good quality agricultural land.

It includes an area close to the Letcombe Brook which is susceptible to flooding and is an important wildlife area.

The village school is already at overcapacity and could not cope with a major expansion of the population.

The village is already a rat run with a dangerous amount of through traffic. Additional traffic would be adding to the danger within the village.

The A338 is already at full capacity with slowmoving traffic backing up from Wantage at peak times. The expansion of Wantage and Grove will further increase traffic. Even more housing of this proposed site will further add to the problem.

The village has flooded severely in the past on several occasions. Building on a Greenfield site upstream of the village will add further risk. The Brook takes the treated sewage from Wantage and Grove already. There is grave concern that the existing proposed expansion of these areas will risk overloading of the Brook, even without additional houses in Hanney.

There are poor transport links to anywhere other than Wantage and Oxford. The development is not sustainable. The majority of the occupants will need to use cars to travel to work in the science areas, to shop or to access leisure facilities.
