NOTICE OF THE ADOPTION OF THE VALE OF WHITE HORSE LOCAL PLAN 2031 PART 1: STRATEGIC SITES AND POLICIES

In accordance with Regulation 25 (Publication of the Recommendations of the Appointed Person), Regulation 26 (Adoption of a Local Plan) and Regulation 35 (Availability of Documents) of the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended), Vale of White Horse District Council hereby give notice of the formal adoption of the Vale of White Horse Local Plan 2031 Part 1: Strategic Sites and Policies on 14 December 2016.

The Local Plan 2031 Part 1 sets out the Spatial Strategy and strategic policies for the district to deliver sustainable development. It identifies the number of new homes and jobs to be provided in the area for the plan period up to 2031. It makes provision for retail, leisure and commercial development and for the infrastructure needed to support them. The Local Plan 2031 Part 1 sets out the Spatial Strategy for the location of development across the district and allocates strategic development sites. It includes district-wide policies to ensure that development contributes to meeting the Strategic Objectives of the plan, such as policies relating to sustainable construction and conservation of the built, historic and natural environment. These district wide policies will replace some of the Saved Local Plan 2011.

The Local Plan was subject to an independent examination conducted by an Inspector appointed by the Secretary of State. The Adopted Local Plan incorporates modifications recommended by Inspector as set out within the Appendix to the Inspector's Report pursuant to Section 23 of the Planning and Compulsory Purchase Act 2004.
