Statement to Inform Habitats Regulations Assessment of the Schedule of Proposed Modifications

Following the hearings into the Vale of White Horse Local Plan Part 1, the Planning Inspector has identified a series of necessary Main Modifications in order to ensure the plan is sound. From an HRA point of view these changes are not significant and do not merit a further iteration of the full HRA report. Rather, this statement discusses the relevant changes to policy. Note that we have not listed modifications below to wording other than policy text, except where it may have an HRA relevance. In summary, none of the changes made to the plan since the previous HRA result in changes to the conclusions of that HRA.
