Footnote 3: A valid ticket or parking permit will be required to be displayed during a charging period at those car parks where charges are payable, including those periods when a charge is not payable.

Footnote 4: Hales Meadow car park to be used exclusively by market traders on market days.

*New residents permits are no longer available and the removal of discounts on current resident permits is to be phased out over a four-year period from 2020 to 2024.
