Nomination papers must be delivered to the Deputy Returning Officer, 135 Eastern Avenue, Milton Park, Milton, Abingdon, Oxfordshire, OX14 4SB on any day from the publication of this notice, on Monday to Friday 10am to 4pm (excluding bank holidays) but no later than **4pm on Thursday 8 April 2021**.
2. Forms of nomination for County Elections may be obtained at 135 Eastern Avenue, Milton Park, Milton, Abingdon, Oxfordshire, OX14 4SB from the Deputy Returning Officer who will, at the request of an elector for any electoral area, prepare a nomination paper for signature.
3. If any election is contested the poll will take place on **Thursday 6 May 2021**.
4. Applications to register to vote must reach the Electoral Registration Officer by midnight on **Monday 19 April 2021**. Applications can be made online: <https://www.gov.uk/register-to-vote>.
5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at 135 Eastern Avenue, Milton Park, Milton, Abingdon, Oxfordshire, OX14 4SB by **5pm on Tuesday 20 April 2021**.
6. New applications to vote by proxy at this election must reach the Electoral Registration Officer at 135 Eastern Avenue, Milton Park, Milton, Abingdon, Oxfordshire, OX14 4SB by **5pm on Tuesday 27 April 2021**.
7. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at 135 Eastern Avenue, Milton Park, Milton, Abingdon, Oxfordshire, OX14 4SB by **5pm on Thursday 6 May 2021**. The physical incapacity must have occurred after **5pm on Tuesday 27 April 2021**. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after **5pm on Tuesday 27 April 2021**.
