Why do you need to do this Equality Impact Check?

OUTLINE OF THE DRAFT STRATEGY / POLICY YOU ARE CHECKING:

1. What are the aims and objectives of this draft strategy/policy?

Production of a new Design Guide to cover both South and Vale districts (currently both districts have separate design guides; adopted in 2016 for South and 2015 for Vale)

The Joint Design Guide will be a Supplementary Planning Document (SPD). SPDs build upon and provide more detailed guidance about policies in the Local Plan. They do not form part of the Local Plan itself and they are not subject to independent examination, but they are material considerations in determining planning applications.

Since the project began, the scope of the design guide has had to broaden to bring design guidance and practice up to date with the current revisions of the NPPF, National Design Guide, National design code and Building regulations.

This Equality Impact Assessment (EIA) specifically covers the draft Joint Design Guide Supplementary Planning Document (SPD).

Planning officers, property developers, planning applicants, agents, landowners, design consultants, Councillors, Town and parish councillors and neighbourhood groups, new and existing residents.

The Joint Design Guide is supplementary to the Local Plans for South Oxfordshire and Vale of White Horse District Councils. An EIA for the Joint Design Guide is now being carried out. An EIA was carried out as part of the current South Oxfordshire Design Guide Supplementary Planning Document November 2016 which also seeks to raise the quality of design (including inclusive accessibility) in new development in the district.

As a result of that EIA some editorial changes were made. The supporting text within the current adopted Design Guide included references to "the needs of all users including the elderly, disabled, parents and carers". Other edits were made within the design

principles such as adding a principle around 'seeking to improve access and movement for all users'. A definition for inclusivity was included within the glossary. This negated the need to make reference to each relevant protected characteristic within a policy as we could inadvertently forget a relevant group. Therefore, in some policies it says 'all users'. These edits have been carried forward into the new draft Joint Design Guide.

Reference to the Fieldfare Trust guidance ('Countryside for All' – A good practice guide to Disabled People's Access in the Countryside) has also been made.
