Introduction

The Infrastructure Funding Statement (IFS) is an annual report that summarises how developer contributions are secured, received and spent from new developments in the local area. The statement also indicates how the Vale of White Horse District Council intends to allocate its Community Infrastructure Levy (CIL) funds through our spending strategy, which sets out the process that we will undertake for allocating CIL receipts.

The council is required to publish the IFS annually, in accordance with Regulation 121A, Schedule 2, Section 1 of the Community Infrastructure Levy Regulations (2019 amendment).

Being in a two-tiered local government structure means that Oxfordshire County Council (OCC) will also publish an IFS, which will include details of Education and Transport contributions for our area.

Throughout the IFS there will be references to the following definitions:

Agreed – Contributions that have been agreed within a signed legal document. These contributions have not been collected / delivered and if the planning applications are not implemented, they will never be received.

Received – Contributions received, either non-monetary or monetary that have been transferred to Vale of White Horse District Council.

Allocated – Contributions that have been received and allocated to specific projects.

Spent / delivered – Monetary or non-monetary contributions that have been spent / delivered.

The reported year - unless stated otherwise, this refers to the period 1 April 2022 to 31 March 2023.

Background

There are a range of methods in place to ensure that new developments provide the necessary infrastructure for our area.

Community Infrastructure Levy (CIL) is a mechanism that allows councils to raise funds in the form of a levy. The CIL Charging Schedule was first implemented in 2017 for the Vale of White Horse District Council and helps fund infrastructure needed to support growth in the area. The charging schedule was reviewed in 2021, following the adoption of the Vale of White Horse Local Plan 2031 Part 2, and a new charging schedule was adopted in November 2021.

The CIL receipts are divided into three categories:

- a. Administration costs at five per cent
- b. Neighbourhood portion at 15 per cent or 25 per cent, depending on whether a Neighbourhood Plan has been adopted
- c. Infrastructure portion the remaining balance following allocation of the administration and neighbourhood portion, administered by us in-line with our CIL spending strategy.

Section 106 Agreements (S106) are legal agreements made between the developer and the Vale of White Horse District Council to help alleviate the impact of development and to make it acceptable in planning terms. The obligations within a S106 may be financial or non-financial and are used alongside CIL to ensure the right infrastructure is provided for our area.

S106 agreements may:

- a. Secure social housing (affordable housing)
- b. Secure financial contributions for social housing and infrastructure
- c. Restrict the development in a specified way
- d. Secure non-financial infrastructure such as open spaces and play areas.

Section 278/38 agreements are legal agreements related to roads, cycle paths and footways, and are used to help fund alterations to highways and the adoption of new highways. These agreements are made between the developer and Oxfordshire County Council (OCC).

Financial Report for 2022/23

During the reported year, the Vale of White Horse District Council secured £6,747,759 of developer contributions through CIL and S106. A total of £4,141,756 was expended in 2022/23 on key infrastructure needed to support the growth of the district. The Financial Report for the reported year, shown in Appendix, provides a breakdown of funding secured, received and spent.

In the period following the reported year, a further £2,132,000 of CIL funds has been allocated to infrastructure projects. A breakdown of ongoing CIL funded district council projects is shown in the planned use of developer contributions section on page 13.

Local communities have benefited from funds secured through developer contributions with a total of £1,064,282 of CIL funds being transferred to town and parish councils in 2022/23.

Following the reported year of 2022/23, £1,948,327 made up of CIL contributions collected between October 2021 and September 2022, has been released to OCC for essential education and highways improvements across the district. An additional \pounds 1,961,305 was transferred to OCC during the reported year for the same purposes.

Affordable housing delivery

Affordable housing is provided on most new housing developments, through the application of planning policy. Affordable homes are defined by national guidance and are designed to meet the needs of households and individuals that can't meet their own housing needs in the market. Affordable homes are made available for rent and various low-cost forms of home ownership. We work in partnership with Registered Providers (housing associations), housebuilders and others to deliver these types of homes.


Town and parish councils - CIL allocation

Neighbourhood planning gives communities the power to develop a shared vision for their area and helps to shape, direct and deliver sustainable development. They can also help to influence local planning decisions as part of the statutory development plan.

In line with CIL regulations, the neighbourhood portion stands at 15 per cent, or 25 per cent if a Neighbourhood Plan has been adopted and is transferred to town and parish councils that have a CIL liable development in their ward. Payments are made in the April and October following receipt of the CIL contributions from developers. For the reported year, £1,064,282 of neighborhood CIL was transferred to town and parish councils.

For details of which towns and parishes have a neighbourhood plan and the support available from the council for neighbourhood planning groups, please visit whitehorsedc.gov.uk/neighbourhoodplans.

Town and parish councils that have received CIL funding must report what they have spent the money on to the council on an annual basis. The town and parish council expenditure reports are on our <u>website</u>.

Planned use of developer contributions

Strategic infrastructure priorities for our district are also identified in the Oxfordshire Infrastructure Strategy (2017), which sets out the infrastructure requirements for the county from 2016 to 2031 and beyond. This document was produced with the other five local authorities in Oxfordshire and with the Oxfordshire Local Enterprise Partnership. This work was recently reviewed and updated by consultants CityScience and a stage one report was published in January 2022, which outlines requirements up to 2040. The Oxfordshire authorities, through the Future Oxfordshire Partnership (FOP), have undertaken a gap analysis of OXIS 2022 to understand what additional infrastructure the county will need. Collectively, the Councils are considering the best way to take this work forward.

The council has a robust delivery pipeline of affordable homes which will be built in the coming year. This pipeline comprises houses and apartments for rent, and for low-cost home ownership, in many parts of the district. At the same time, we continue to secure further new homes through our planning policies, which will ensure a future supply of much needed affordable housing throughout the district.

Although not a health care authority, the Vale of White Horse District Council assign 20 per cent of the infrastructure proportion of CIL for health care projects supported by the Buckinghamshire, Oxfordshire and Berkshire West Integrated Care Board. The balance of these funds at the end of the reported period stood at £2,443,382. Allocation to specific schemes and spend of these funds on health care infrastructure, will be reported in future funding statements.

In line with the council's CIL spending strategy, 50 per cent of the infrastructure proportion is allocated to OCC for use on transport, education, libraries and household recycling centres. £1,948,327 of CIL funds have been released to OCC in 2022/23. Full details of projects supported by this funding will be included in the county council's infrastructure funding statement and the transfer of these funds will be recorded in the statistical report of Vale of White Horse District Council's 2023/24 statement.

CIL Funding Requested	£300,000
Project Description	Civil Parking Enforcement (CPE) has now been rolled out in Cherwell South and Vale Districts from 1 November 2021. As a result, requests are being received to modify and replace existing traffic restrictions and to implement new Controlled Parking Zones (resident parking schemes) in Market Towns across the County.

These schemes will assist communities to secure resident parking, reduce congestion and improve traffic flows (including bus punctuality) and ensure that the correct restrictions are in the correct places. CIL funding is sought to assess, design and implement new CPZ's and modify restrictions in Market Towns in
Vale of White Horse area.

Project	Abingdon: Northcourt Road – Zebra Crossing
CIL Funding Requested	£75,000
Project Description	The provision of a zebra crossing which will ease access for pedestrians along a popular corridor with many amenities and housing on each side of the road.

Project	Wantage: Denchworth Road -Upgrade existing Zebra Crossing to Puffin Crossing
CIL Funding Requested	£160,000
Project Description	The upgrading of a zebra crossing to a signal-controlled puffin crossing to facilitate access to the school and bus services to serve the increasing population.

Project	Cumnor: Cumnor Hill – Arnold's Way Puffin Crossing
CIL Funding Requested	£160,000
Project Description	A pedestrian crossing to facilitate access to the bus stop in this increasingly densely populated area which will help to encourage and facilitate the use of sustainable transport on a busy bus corridor.

Project	Cycle parking onsite at Dunmore Primary School

CIL Funding Requested	£12,527
Project Description	Our partners at Active Oxfordshire are currently awarding Community Outreach funding to applicants who wish to make active travel improvements, one of which is to install new cycle storage racks outside Dunmore School in Abingdon. Due to pressures on the funding pot, we are not able to fund the cycle storage that is being requested at the school. OCC is very much seeking to put active travel at the top of the hierarchy of transport modes. By delivering cycle parking at Dunmore Primary school, we offer real modal choice to pupils and possibility even more importantly, start that step changing in attitudes towards active travel to encourage young people to use active travel from early years to carry forward into their adult life.

Project	Wayfinding signage, Abingdon
CIL Funding Requested	£50,000
Project Description	To improve wayfinding for active travel modes within Abingdon. At the moment there is very limited wayfinding signage in Abingdon and the projects seeks to improve it to produce maps and put measures in place on the public highway that highlight key destinations for active travel users to improve their accessibility across the town.
	OCC is very much seeking to put active travel at the top of the hierarchy of transport modes. By delivering active travel way finding we make it more attractive to walk and cycle across the town as key routes and destinations will be highlighted and easily found.

Project	Bike Libraries for Abingdon
CIL Funding Requested	£20,000
Project Description	To introduce two bike libraries in Abingdon (exact location to be determined with community input).
	A bike library is a secure cycle storage unit which houses old and second-hand bikes for members of the community to loan (usually for long periods i.e. until the child outgrows it).
	The library also includes a trained mechanic/trainer who can fix the bikes and help residents to learn how to cycle safely, hand out helmets etc. When children grow out of their loaned bike they are returned to the library, it is checked and then loaned out to a new child. As a result there are no issues with bikes being discarded.

The bike libraries will operate from within school grounds.
OCC is very much seeking to put active travel at the top of the hierarchy of transport modes. By delivering bike libraries we offer the opportunity for those who may not be able to afford a bike to make that step change in choosing to cycle and hopeful gaining better health benefits as a result as well as getting younger children to choose active travel as a first means of transport choice.

Project	Radley CE Primary School – Expansion
CIL Funding Requested	£1,000,000
Project Description	Expansion of Radley Primary School to 1 form entry (1FE)
	Expansion of Radley CE Primary School from 0.5FE to 1FE. This project provides 105 additional primary school places. At the same time the nursery capacity will be increased from 48pte to 52pte. The project includes the construction of four new classrooms and expansion of the school hall and kitchen.

Project	Shrivenham CE Primary School – Relocation and Expansion
CIL Funding Requested	£136,800
Project Description	 This project will deliver additional school places by relocating and expanding Shrivenham CE Primary School. The relocation is required as the existing school site is too small to accommodate the expansion. The new school site has been secured via a s106 agreement. The expansion of the school from 1FE to 1.5FE will create 105 additional pupil places required to mitigate the impact of new housing.



Radley CE Primary School Expansion delivered by Oxfordshire County Council supported by CIL funds of £2,579,976 collected by Vale of White Horse District Council between 2019 and 2022.
