We are writing to express our sincere gratitude for all that you have done in support of the UK Government's work to resettle those on the Afghan Relocations and Assistance Policy (ARAP) arriving in our country. You will know that this matters enormously, bringing these individuals and their families to the UK and helping them to start their new lives is a moral obligation for this Government, given all they did to aid British efforts in Afghanistan. You have played a significant part in making this happen and we are hugely grateful for your support.

The Ministry of Defence is providing fifty-seven settled Service Family Accommodation (SFA) properties for ARAP families in Vale of White Horse. Twenty-four of these have already been leased, meaning that twenty-four families now have a home from which to begin their lives in the UK. Thank you for your hard work in making this happen.

In addition to this, we have activated twenty-four transitional SFA properties in your area. These will provide many families with a place to stay until their settled homes are made ready. We aim to close these facilities by Easter.

As you know, we owe a debt of gratitude to this cohort who supported our efforts in Afghanistan, and it is essential that we move at pace to provide them with appropriate housing. However, we also want to acknowledge the impact that this will be having on local resources. HMG is asking a lot of Local Authorities, and we know that this work is adding to very real pressures.
