Decision regarding the designation of Kingston Bagpuize with Southmoor as a Neighbourhood Area under Section 61G of the Town and Country Planning Act 1990 as amended.

This letter confirms that on 2 April 2024, the Head of Policy and Programmes at Vale of White Horse District Council, designated the area shown on Map 1 below as the 'Kingston Bagpuize with Southmoor Neighbourhood Development Plan Area'.


